SCHEDULE PS/SC - Public Buildings and Small Commercial

AVAILABILITY

Available for schools, churches, other public buildings, three-phase residential, and small commercial consumers at any point on or near the Cooperative's distribution lines, with all service being supplied through one meter and subject to the rules and regulations of the Cooperative. The rated capacity of any single-phase motor served under this Schedule shall not exceed 5 horsepower.

TYPE OF SERVICE

Single-phase, 60 hertz, at available secondary voltage. Service may be three-phase (not to exceed 50 KW) if three-phase lines are on or near the premises and necessary for effective use of electric energy desired and subject to prior special arrangements with the Cooperative.

MINIMUM MONTHLY CHARGE

Monthly charge shall be \$27.00 plus \$1.00 per KVA over 10 KVA installed transformer capacity.

LATE PAYMENT CHARGE

The above rates are net. In the event the current monthly bill is not paid within sixteen (16) days of mailing date, a five percent (5%) penalty will be added to the bill. If the due date falls on a holiday or weekend, the due date for payment purposes shall be the next work day after the due date.

TERMS OF PAYMENT

The above rates are total; bills become delinquent if unpaid sixteen (16) days after issuance (postmarked date). If the due date falls on a holiday or weekend, the due date for payment purposes shall be the next work day after the due date. Service shall be disconnected if the bill has not been paid within twenty-six (26) days from date of issuance providing proper notice has been given at least ten (10) days prior to the stated date of disconnection.

Rate to be effective upon approval of tariff by the Board of Directors of Bowie-Cass Electric Cooperative, Inc.
